This matter came on before the Court on the Motion of the Debtors, Evergreen Homes, LLC, Case No. 07-51261, Evergreen Investment Corporation, Case No. 07-51262, and Evergreen Builders, LLC, Case No. 07-51263, for joint administration of the Chapter 11 estates of the above captioned Debtors and Debtors-in-Possession (collectively, "Debtors"). The Court having reviewed the Motion finds that (a) the Court has jurisdiction over this matter pursuant to 28 U.S.C. §§ 157 and 1334, (b) this is a core proceeding pursuant to 28 U.S.C. § 157 (b)(2), (c) Notice of the Motion was sufficient (d) there are no objections to the relief requested in the Motion; and the court having determined that the legal and factual bases set forth in the Motion establish just cause for the relief granted herein;

**IT IS HEREBY ORDERED THAT:**

1. The Motion is GRANTED.
2. The joint administration of the Chapter 11 cases of Debtors Evergreen Homes, LLC, Evergreen Investment Corporation and Evergreen Builders, LLC is hereby ordered and the cases are hereby consolidated for procedural purposes only.
